How has your school's spending improved PE attainment?	All children have had wider opportunities to learn and play different sports / activities this year, including Basketball, Cheer Leading, Boogie Bounce, Mindful Movement and Street Dance.

	Children's data outcomes are improving.
How has your school's spending increased pupil PE and sport activity levels?	More than two thirds of the school population have accessed at least one afterschool or holiday club. This is an improvement of 14% on the previous year. Introducing different sports has engaged and energised the children and they tell us they love it!
How has your school's spending increased school sport participation?	We have spent over and above out Sport's Premium grant, as we wanted to drive up children's participation in activity. This has been successful. We have also liaised with other schools to loan equipment and run joint clubs across the community.
How has your school's spending increased pupil participation in extra-curricular activities?	Offering different sports / activity clubs this year, has led to an increase in sign up. The systems in place are well-organised and all done remotely, so parents can access information about what's coming up and talk to their child about it.
How has your school's spending increased staff training and continued professional development (CPD)?	In this academic year, staff have accessed specific training on playground games, swimming, scooters and boogie bounce.
How has your school's spending increased staff participation in extra-curricular activities and school sports competitions?	We have invested heavily in increasing our out of school offer to children. Support Staff and Teachers have been fully involved in adding to the provision, enabling more children to be able to access physical activities and learn new skills.
How has your school's spending improved swimming attainment?	All Y4 and Y5 have had a 2 week block of intensive swimming lessons in the Autumn Term. Top up for Y6 has been included to support those less confident or with specific physical needs. As a result, more than 85% of the children have met the 25m target.
How has your school's spending improved water safety awareness?	Children are taught about water safety as part of their swimming lessons. In addition, we have had an assembly delivered by
